## Aims and Scope

*Cosmos + Taxis* (C+T) offers a forum to those concerned that the presuppositions of the liberal tradition have been severely corroded, neglected, or misappropriated by overly rationalistic and constructivist approaches. The hardest-won achievements of the *classical* liberal tradition have been the wrestling of epistemic independence from overwhelming concentrations of power, monopolies and capricious zealotries.

C+T publishes papers on complexity, broadly conceived in a manner that is accessible to a general readership with particular emphasis on political economy and social philosophy. C+T is not committed to any particular school of philosophical thought or philosophical style.

C+T offers a forum distinctively engaging the growing confluence of interest in **situated and distributed** liberalism emanating from the Scottish tradition, Austrian economics, and non-Cartesian philosophy.

## General Editorial Information

C+T is operated under the auspices of the Department of Philosophy, Political Science, and Economics at The University of British Columbia Okanagan. **C+T does not assume responsibility for the views expressed by its contributors.**

In addition to articles and reviews, C+T offers an opportunity for guest editors to lead thematic issues, book symposia and *festschriften*. Inquiries should be addressed to the Managing Editor.

C+T typically publishes six double issues per annum, is licensed under a Creative Commons Attribution 4.0 International License and is listed in the Directory of Open Access Journals (<https://doaj.org/toc/2291-5079>). Contributors are thus encouraged to disseminate widely, pointing to a dedicated permanent uniform resource locator. C+T gladly allows permission to republish items with the original C+T citation. Authors retain full copyright to their work: C+T retains copyright as a curated entity.

C+T does not have article processing- nor any submission- charges. Professionally bound and printed hard copies of C+T are available on demand at a cost: please address inquiries to the Managing Editor.

Submitting an article to C+T implies that it is has not already been published (either in hardcopy or online) and is not under consideration for publication elsewhere. C+T will endeavor to undertake the refereeing process in a timely manner (i.e. a publication decision will be made available within three months).

C+T only accepts digital submissions, i.e. as a Word document. Submissions should be made to the Managing Editor.

## Elements of Style

Submissions should be in English: American, UK and Canadian spellings and punctuation marks are acceptable so long as they adhere consistently to one pattern.

Accepted papers (articles, surveys, and reviews) usually range between 3,500 and 7,500 words. However, C+T are willing to consider manuscripts as long as 12,000 words (and even more under very special circumstances).

Papers should be double-spaced, in 12-point Times New Roman font and *not* double justified.

Please, **no** embedded footer or header details.

Abstracts, keywords and Journal of Economic Literature classification codes are optional.

Citations should be made in author-date format. **Please, no embedded citations or links (static only).** A reference list of all works cited should be placed at the end of the article. **Unless a reference is solely available as an online item, do not add any links.**

Mathematical formulae, graphs and other images must be submitted in a separate Word document indicating where in the body of the text they should be placed.

All notes should be as **endnotes**. Please be very judicious with the number of notes deployed.

Line spacing should be at 1.5 with quotations longer than 20 words at single spacing and indicated by a separate indented paragraph.
